**DUTIES AND RESPONSIBILITIES**

**DUTIES and RESPONSIBILITIES:**

DUTIES: This position is located at Greeley Air National Guard Station, Greeley, CO. Its purpose is to provide superior leadership guidance and support to the 233d Space Communications Squadron.

1. Leads team of cyber personnel
2. Provides oversight for current and future mission systems and communication infrastructure, ensuring product quality, statutory and regulatory compliance
3. Oversees deployment and exercise preparation of Cyber teams, equipment and supplies
4. Plans and prepares for mission. Reviews mission tasking, intelligence, terrain and weather information. Supervises mission planning, preparation and crew briefing/debriefing. Ensures equipment and crew are mission ready prior to execution/deployment.
5. Operates weapons system(s) and commands crew. Performs, supervises, or directs weapons system employment and associated crew activities.
6. Makes mission and personnel recommendations to squadron commander
7. Perform additional duties as assigned

## DUTIES and RESPONSIBILITIES (Cont'd):

### SPECIALTY QUALIFICATIONS:

1. Must meet the Air Force physical fitness standards.
2. Must hold a Secret security clearance with eligibility for Top Secret .
3. Any AFSC is eligible to apply for this position; 3D, 1C6, 1N experience are desirable.
4. Must maintain worldwide deployable requirements.
5. Knowledge is mandatory including electronics theory, information technology, telecommunications and supervisory and control systems including cryptography, vulnerability assessment and exploitation techniques. Additionally knowledge will include operational planning, governing cyberspace operations directives, procedures and tactics.
6. Experience with missile warning, space electronic warfare, cybersecurity, or instructor duty desirable.
