# Supporting Veterans on Colorado's Western Slope

The Western Region One Source (WROS) in Grand Junction, Colorado is a comprehensive resource center for Veterans and their families. The facility was created with the goal of providing a single location where Veterans can access a wide range of services and support. Built out of a Colorado National Guard Armory, the WROS offers a one-stop-shop for Veterans who need assistance and resources to help them transition to civilian life.

From health care to education and beyond, the facility hosts a wide range of programs and services designed to meet the needs of Veterans and their families. This includes access to medical care, mental health services, rehabilitation services, job training and placement services, as well as information on college programs and financial aid. The WROS also provides assistance with finding affordable housing, home ownership programs, and foreclosure prevention.

"The Western Slope Veteran community can often end up isolated from the rest of the State," said DVA Director David Callahan in a recent testimony to the State Legislature. "The WROS helps the Division stay connected."

In addition to its services, it also serves as a source of information and advocacy for Veterans. The WROS works to educate the public and policymakers on the needs of Veterans and to ensure that Veterans receive the benefits and support they have earned. It also provides Veterans with a voice, advocating on their behalf to secure the resources they need to succeed.

The one-stop center also provides a safe and welcoming space, where Veterans can receive the help they need, connect with others who have faced similar challenges, and build a sense of community. It also offers a variety of support groups and events, where Veterans can come together and share their experiences, build relationships, and support each other.

# Legislative Update: DMVA actions at the Capitol

The Department of Military and Veterans Affairs is part of the executive branch of the Colorado government. As a result, all State employees ultimately report to the Governor.

While the Governor has significant authority over much of the State government. There are a couple of areas where his powers are limited: the creation of laws and the setting of the State budget. These two items are up to the legislature.

Passing a law through the State government is very similar to passing one through the US Congress. All State laws begin in the legislature, where they are sponored by either a State Representative or Senator.

Once a sponsor is secured, the new bill is drafted and run through whichever chamber the initial sponsor is a member of, the House of Representatives or the Senate.

Once a bill has passed through the initial chamber, it is sent to the other chamber for passage. Once it has passed through both chambers of the legislature, it is sent to the Governor's desk where it is either vetoed or signed into law.

This process affects you as state employees in multiple ways including the creation of new positions in the department, major changes in salary, and how state law affects the department, which can lead to changes in workload or responsibilities.

As the legislative liaison, it is my job to represent the DMVA at the Capitol. Working through the Governor's office, I take steps to ensure that legislation that would harm the department is not passed.

It is also my job to ensure that certain legislation *does* get passed. I work hand in hand with the Governor's office and State legislators to pass bills that will benefit the department and the employees in it.

The State legislative session runs from January to May each year. This year, the DMVA is running two agency bills through the State legislature. This article will explain what they are, where they are in the process, and how they will benefit you if they pass!

## HB23-1053: Cemetery Gifts, Grants, and Donations

HB23-1053 is a bill that will allow the Veterans Memorial Cemetery of Western Colorado to expend the gifts, grants, and donations that it takes in each year.

This bill was initially sponsored in the House by Representatives Anthony Hartsook (R) and David Ortiz (D). It was picked up in the Senate by Senators Rachel Zenzinger (D) and Janice Rich (R).

This bill passed through the House nearly unanimously and will be headed to the Senate in the coming weeks.

Should this bill pass, it would significantly benefit the Veterans Cemetery by allowing them to source other methods of funding for grounds improvement, maintenance, and infrastructure development. Thus, allowing State employees to have a greater impact on the Veterans community on the Western Slope.

#### SB23-036: Removing the Division of Veterans Affairs from Property Tax Exemption Verification

I know that title is a mouthful, but this bill will greatly help alleviate the workload on employees under the Division of Veterans Affairs!

Currently, the Division of Veterans Affairs spends over 1,000 hours a year verifying documents surrounding property tax exemptions for disabled veterans before sending them to county tax assessors.

However, due to modernization improvements in the US Department of Veterans Affairs at the federal level, most Veterans can fill these documents out themselves and sending them to their own tax assessors.

This bill will change State law to remove the Division from having to do this each year.

This bill was initially sponsored by Senators Byron Pelton (R) and Lisa Cutter (D). It was picked up in the House by Representatives Ryan Armagost (R) and David Ortiz (D).

Currently, this bill is at the Senate Appropriations Committee.

Should this bill pass, it would take a massive workload off the shoulders of State employees in the Division of Veterans Affairs. This would allow the hours previously spent doing verifications, to be used to better serve Veterans throughout the State of Colorado.
