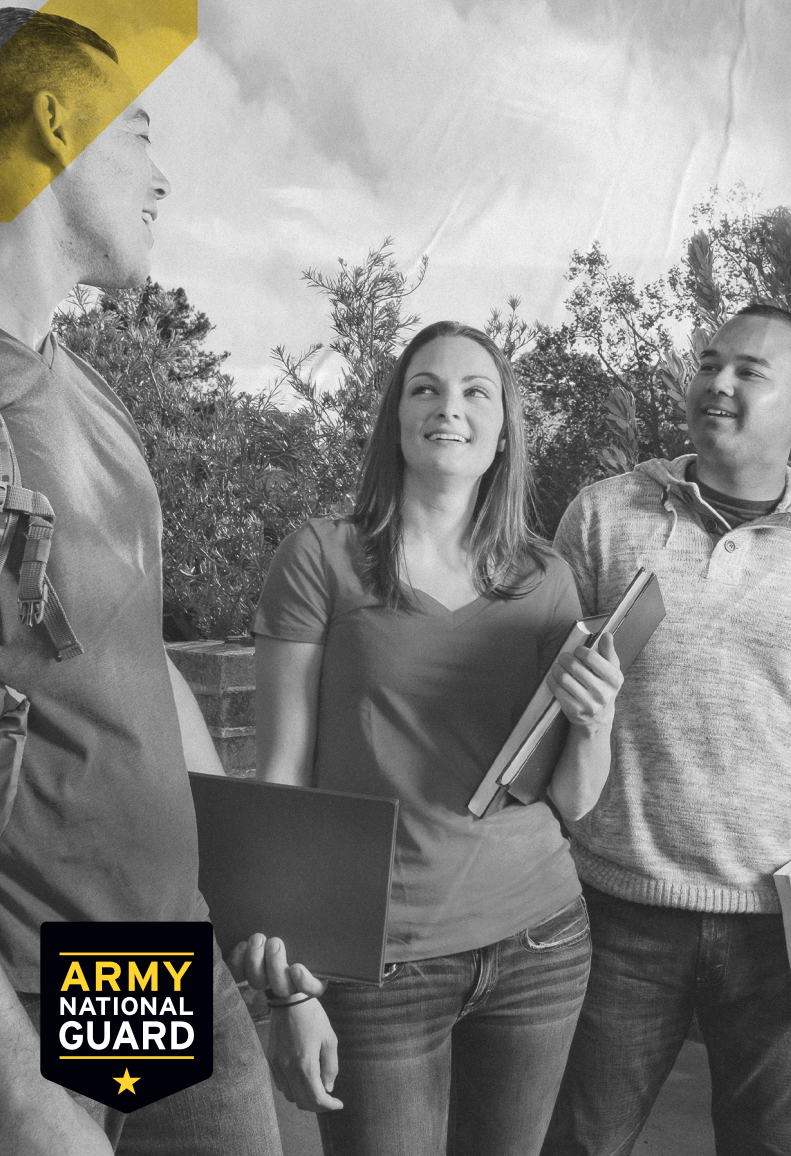

## WHAT IS IT?

- The Fry Scholarship is an education program for surviving family members of a Service member who died in the line of duty after September 10, 2001 (Reference: Title 38 USC Chapter 33, DoDI 1341.13).

## HOW DO SURVIVING DEPENDENTS QUALIFY?

- Be the surviving spouse or child of a service member who died in the line of duty on or after September 11, 2001
  - Spouse may still receive Dependency and Indemnity Compensation (DIC) while using the Fry Scholarship.
  - If the service member died prior to August 1, 2011, the child may be eligible for both DEA and the Fry Scholarship:
    - May only use one program at a time,
    - Combined benefits are capped at 81 months.
  - If the child is receiving DIC, they will need to give up those payments.
- Rules for Children who are serving or previously served in the Armed Forces:
  - Must relinquish eligibility to Montgomery GI Bill- Active Duty (MGIB-AD, Chapter 30) or Montgomery GI Bill- Selected Reserve (MGIB-SR, Chapter 1606).
  - Character of Service does not affect Fry Scholarship eligibility.
  - May qualify for 36 months of Fry Scholarships and another 36 months of Post-9/11 based on own service.

## WHAT BENEFITS DO SURVIVING DEPENDENTS RECEIVE?

- Up to 36 months of Post-9/11 GI Bill benefits at the 100% payment tier
  - Tuition and Fees
    - 100% of in-state tuition if attending a public school
    - Max tuition payment of \$27,120.05 per year for private or foreign school (1 Aug 2023)
  - Book and Supply Stipend
    - Up to \$1,000 per academic year (\$41.67/credit hour)
  - Monthly Housing Allowance
    - Equal to BAH rate - E-5 with dependents
    - Based on zipcode of campus where attending class
    - MUST be attending more than half-time to qualify
    - If attending only online classes: **\$938** per month (1 Aug 2023)
- Timeline/Expiration of Benefits:
  - Spouse's eligibility expires on remarriage
  - Child's eligibility begins depending on when the child turns age 18 or graduates from high school (whichever was first):
    - If the child turns age 18 or graduates high school prior to January 1, 2013, eligibility expires on the child's 33rd birthday.
    - If the child turns 18 or graduates high school on or after January 1, 2013, eligibility never expires.
