## Ways to Pay for College

### State Tuition Assistance (STA)

Up to \$8500/yr; \$4250/Semester

Must be in the COARNG or COANG for 6 months

<https://www.colorado.gov/dmva> and click on Tuition Assistance



### Federal Tuition Assistance (FTA)

Up to \$4000/yr; \$250/SH

### GI Bills

CH 1606: \$384/month (full-time rate)

Kicker: \$200-\$350; Must have contracted for this benefit

CH 30: \$1994 (stipend) Must have paid in \$1200; Active Duty (AD) Benefit

CH 33 (Post 9/11): 100% tuition/fees, Private Schools \$23,671.94; AD Benefit



## Incentives

### Bonus and Student Loan Repayment (SLRP)

Must have contracted for incentive at the time of enlistment/re-enlistment

**Bonus:** payments are eligible to payout once you become DMOSQ and on the future anniversary date specified in your bonus addendum

**SLRP:** payments are made annually after your anniversary date

SLRP annual paperwork required—DD 2475 and National Student Loan Database System (NSLDS) loan data

Eligibility requirements and payment information can be found in your bonus addendum

### Transfer of Education Benefits

After 6 years of service and 90+ days of AD time, Soldiers can transfer their CH 33 benefits to their dependents/spouses.

1. Decide what career you'd like to pursue.

2. Choose a school and program.

3. Discuss ways to pay for college by contacting your school, Mary Lantz, or Dee Jno-Baptiste.

4. Submit your Joint Services Transcripts (JST) for evaluation. Visit [jst.doded.mil](http://jst.doded.mil) to get a copy of suggested civilian credits from your military training.
