AREA OF CONSIDERATION: This position is open to current members of the Colorado Air National Guard in the grades of: E6 to E7 (Unless otherwise specified in "WHO MAY APPLY" above). Individual selected will receive an Active Guard Reserve (AGR) Tour with the Colorado Air National Guard. In order to be considered for this position applicants must meet minimum qualifications as outlined on this announcement.

If any of the required documents are not reasonably available to you, a brief Memorandum For Record (MFR) will be submitted citing the documents missing with a short explanation necessary to certify the airman as eligible. **Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.**

POSITION COMPATIBILITY REQUIREMENTS:
The individual(s) must be a projected member of the Colorado Air National Guard and qualify for and be placed in the following compatible AFSC/AOC prior to receiving AGR orders: 1P07

MINIMUM APPOINTMENT REQUIREMENTS:

1. Must possess a current Secret clearance.
2. Must hold 1P071A AFSC.
3. Competition for higher graded UMD positions (E7) does not guarantee immediate promotion. Promotion will be determined after a merit review board, promotion recommendation by the AAG.

BRIEF JOB DESCRIPTION:

1. Refer to Air Force Enlisted Classification Directory (AFECD) for specific duties associated with this AFSC.
2. Performs other duties as assigned.
3. Showcase team leadership skills in decision-making, development of others, and self.
4. Leverage experience of self and others to advance the AFE team and the aviation mission.
5. Showcase accountability and encourage innovation.
6. Inspects, maintains, packs and adjust AFE such as flight helmets, oxygen masks, parachutes, flotation devices, survival kits, helmeted mounted devices, aircrew night visions systems, anti-G garments, protective equipment, chemical biological protective oxygen masks and coveralls, and other types of AFE and ACBRN systems.
7. Repairs flotation equipment and ACES II Recovery and Drogue parachutes.
8. Evaluates problems and determines feasibility of repair or replacement related to inspecting rubber equipment and parachutes.
9. Uses various types of test equipment such as altimeters, oxygen testers, leakage testers, radio testers, and other types of testers to conduct reliability testing on AFE and ACBRN equipment.
10. Tracks, monitors, updates equipment inspection records, item manufacturer details, and serviceability status of AFE issued to aircrew or prepositioned on-board F-16 aircraft.
11. Forecasts supply and manages stock levels for component replacement requirements.
12. Operates, maintains, and inspects AFE machinery, test equipment, and tools.
13. Performs operator maintenance and service inspections on shop equipment.
14. Stores, handles, uses, and disposes of hazardous waste and materials based on environmental standards.
15. Conducts aircrew continuation training; instructs aircrew on equipment use, operation, and capabilities. Conducts ACBRN training; instructs aircrew on ACBRN donning, doffing, and Aircrew Contamination Control Area (ACCA) and Aircrew Contamination Control System (ACCS) contamination mitigation procedures.
