AREA OF CONSIDERATION: This position is open to current members of the Colorado Air National Guard in the grades of: E6 to E7 (Unless otherwise specified in "WHO MAY APPLY" above). Individual selected will receive an Active Guard Reserve (AGR) Tour with the Colorado Air National Guard. In order to be considered for this position applicants must meet minimum qualifications as outlined on this announcement.

If any of the required documents are not reasonably available to you, a brief Memorandum For Record (MFR) will be submitted citing the documents missing with a short explanation necessary to certify the airman as eligible. **Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.**

MINIMUM APPOINTMENT REQUIREMENTS:

There are no appointment requirements.

BRIEF JOB DESCRIPTION:

Acts on the behalf of the unit commander to plan, organize, and manage the required activities of the civil engineer unit with regards to the PRIME BEEF, Unit Deployment Manager (UDM), and mobility programs for critical essential mission requirements.

Manages deployment/contingency planning for mission accomplishments.

Manages the PRIME BEEF and Mobility programs for the Civil Engineer Squadron (CES). Evaluates the effectiveness of PRIME BEEF and mobility programs for the unit.

Analyzes data and reports. Manages unit deployable and home station equipment and supply program.
Ensures unit personnel complete medical readiness and deployment health requirements IAW AFI 10-250 and AFI 48-122.

Establishes and develops training programs and classes for PRIME BEEF and wartime task training. Analyzes and schedules required training to ensure unit fulfills requirements in accordance with directives. Executes and coordinates TPFDD taskings through the IDRC or DCC IAW AFI 10-401.

Develops unit mobility and deployment plans to meet worldwide contingencies and utilizes required tracking programs and data systems.

Maintains contact with NG ANG/A4XX and Logistics Planners (Log Plans) to ensure currency and accuracy for PRIME BEEF Program requirements.

Performs DCAPES, AF-IT, DRRS reporting. Determines appropriate actions to resolve shortfalls/limitations and performs other duties as assigned IAW AFI 10-210 and AFI 10-403.

Is responsible for managing and documenting all requirements (personnel, training, equipment, etc.) utilizing ARIS. The Prime BEEF Manager maintains current ARIS data.
