Individual selected will receive an Active Guard Reserve (AGR) Tour with the Colorado Air National Guard. In order to be considered for this position applicants must meet minimum qualifications as outlined on this announcement.

If any of the required documents are not reasonably available to you, a brief Memorandum For Record (MFR) will be submitted citing the documents missing with a short explanation necessary to certify the airman as eligible. Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.

5. Copies of last three (3) EPRs/EPBs received
6. Letter of Recommendation from a SNCO or Officer.

POSITION COMPATIBILITY REQUIREMENTS:
The individual(s) must be a projected member of the Colorado Air National Guard and qualify for and be placed in the following compatible AFSC/AOC prior to receiving AGR orders: 3P07

MINIMUM APPOINTMENT REQUIREMENTS:

1. Applicants must currently hold 3P071 AFSC to apply
2. Must be able to obtain a Top Secret/Sensitive Compartmented Information (TS/SCI) clearance within 12 months of hire.
