- Controls access for 17-acre installation ensuring proper credential authentication and detects unauthorized personnel attempting entry
- Executes flight training objectives and assists with training junior Airmen to ensure defense-in-depth for installation and asset protection
- Provided support to the Colorado Army National Guard for Domestic Operations (DOMOPS) and National Guard Reaction Force (NGRF) missions, including disaster relief, civil disturbance, and emergency response

Base Defense Operations Controller

- Manages five Security Forces patrols safeguarding resources providing reliable Force Protection
 - Ensures physical security IAW Higher Headquarters directives while leading response to 467 alarm points affecting Space Force and Air Force assets
 - Supervises the professional and personal development, health, morale & welfare of assigned subordinate Airmen
