**BRIEF JOB DESCRIPTION:**

-Refer to Air Force Enlisted Classification Directory (AFECD) for specific duties related to the 2T371 AFSC.

-Member will be responsible for troubleshooting, repairing and maintaining commercial vehicles and heavy equipment.

-Position is located at Airburst Range, Ft Carson CO. BAH will be calculated using the Fort Carson 80913 zip-code.

-Airburst Range has multiple AFSC's and integration into all facets is necessary for mission accomplishment.

-Will be required to learn and perform Airburst Range Operating Procedures (AFMAN 13-212), checklists and Operating Instructions.

-Will be required to work non-standard duty days to include nights and weekends necessary to support Airburst Range mission requirements.

-Must not be afraid of heights. Duties will include Tower Safety which involves monitoring ground maneuvers/personnel during flight operations.

-Additional range operations duties to include: Threat Simulator Operations, Remote Target Vehicle Operations/Troubleshooting, Weapons Impact Scoring Set Operator, and Wildland Firefighting.
