DUTIES: This position is located at Peterson Air Force Base, Colorado Springs, CO. Its purpose is to provide superior leadership guidance and support to the 138 Space Control Squadron's Mission Assurance Flight.

3. Oversees deployment and exercise preparation of Mission Assurance teams, logistics, equipment and supplies
4. Makes mission and personnel recommendations to squadron commander
