- Operate as a SNCO in the COANG and NCOIC of 233SCS/SCO Future Mission Comms
- Provide leadership and guidance to enlisted force; serve as a senior enlisted leader in various roles
- Support all missions of the 233d Space Group with expert knowledge on all communications operations
- Monitor enlisted development to include PME needs and promotion eligibility as well as AFSC specific development and formal schools; submit promotion recommendations to the SCO Flight Chief.
- Promote health and welfare of personnel and report to the SCO Flight Chief on issues affecting morale, quality of life, workloads and duty performance.
- Support and supervise Traditional, AGR, and Technician enlisted Air National Guard personnel.
- Conduct ACA's and EPR's for assigned personnel.
- Monitor mission training, ancillary training, fitness, and readiness of flight personnel.
- Participate in promotion boards, make recommendations on utilization of personnel.
- Perform additional duties as assigned.

This position located at Greeley Air National Guard Station (GANGS), Greeley CO.

Failure to meet above expectations will be cause for removal and / or demotion.
