DUTIES and RESPONSIBILITIES:

To be selected for this position applicants must be current and qualified 11F AFSC in F-16 or previous fighter type aircraft. Current and qualified F-16 pilot desired. A-10 previous experience will not qualify due to TX course requirements.

Applicants will be required to support the 140th Wing's alert force mission in support of US Northern Command which entails 2-5 monthly 24-hour alert shifts at Buckley Space Force Base, Colorado. Applicants also must be worldwide deployable and able to support combat deployments every 18 - 36 months.

This announcement qualifies for both Traditional and full time positions. Once gained by the COANG as a traditional, full time orders will be offered and opportunities for full time AGR and Technician positions will be announced based on resource availability
