DUTIES AND RESPONSIBILITIES

DUTIES and RESPONSIBILITIES:

The minimum to maximum grade range listed in this announcement IS NOT FOR PROMOTION, but is listed as a requirement TO APPLY to the position.

Must be fully qualified to perform duty as Flight Operational Medical Technician (FOMT).

Member must have at minimum 5-level AFSC in 4N051.

Direct Patient Care: Performs comprehensive clinical nursing tasks, monitors physiological measurements, and administers prescribed medical treatments and therapeutic procedures. Within deployed operations, the element provides vital outpatient, emergency trauma, and cardiac stabilization care, alongside dedicated aerospace medicine support and rapid-response In-Flight Emergency (IFE) coverage.

ASIMS & Grounding Management: Actively maintains and audits the Aeromedical Services Information Management System (ASIMS) to track individual medical readiness (IMR) and manage grounding status

Waiver Tracking: Utilizes Aeromedical Information Management Waiver Tracking System (AIMWTS) to manage flight/SOD waivers under flight surgeon oversight. Attend and/or brief Flight and Operational Medicine Working Group (FOMWG)

Flight and Operational Medicine Duties: Serves as a front-line preventionist who identifies and recommends strategic mitigations to the deployed commander to minimize aerospace, occupational, environmental, and public health risk factors before they impact mission effectiveness. In this capacity, the technician directly supports the flight surgeon by developing comprehensive flying safety and deployment briefings, while actively assisting in aircraft mishap and physiological incident responses, investigations, and formal reporting.

DUTIES and RESPONSIBILITIES (Cont'd):

Physical Exams: Facilitates and administratively processes physical examinations procedures, medical standards, and duty limiting conditions. Knowledge of Physical Examination Processing Program (PEPP)

Schedules and/or conducts in-service training on procedures, techniques, and equipment to include but not limited to tactical combat casualty care (TCCC), emergency triage, and patient litter transport

Obtain immunization back-up technician (IBT) training within six months of being awarded SME position and must maintain biannual training if not currently IBT trained.

Must follow UTA schedule, no quarterly drill offered.
