#### WHO MAY APPLY:

Must be a current on-board AGR in the State of CO within the grade(s) of E7 and E7.

AREA OF CONSIDERATION: This position is open to the grades of E7.

INSTRUCTIONS FOR APPLYING: The documents listed below ARE THE ONLY AUTHORIZED documents to be submitted. If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.

- 1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
- 2. Photocopy of last 5 NCOERs (must submit memorandums for gaps in NCOERS).
- 3. Certified Selection Board Copy of Soldier Record Brief (SRB)
- 4. Security Clearance Verification Memo
- 5. NGB Form 23b, RPAM Statement (National Guard Only)
- 6. Copy of all DD214's / NGB 22's showing all prior service.
- 7. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
- 8. DA 705 with HT/WT annotated(last 3 APFT annotated). IAW HQDA EXORD 164-20, all current valid passing APFT scores remain valid until further notice.
- 9. DA 5500 or 5501-R if applicant does not meet HT /WT standards.
- 10. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.

#### POSITION COMPATIBILITY REQUIREMENTS:

The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 42A

#### MINIMUM APPOINTMENT REQUIREMENTS:

- 1. Must be 42A MOS qualified.
- 2. Must be able to possess a SECRET clearance
- 3. PCS funds subject to availability.
- $4. AGR \ Soldiers \ on \ initial \ tours \ are \ stabilized \ for \ the \ first \ 18 \ months \ and \ are \ ineligible \ to \ apply \ for \ this \ position.$
- 5. During the COVID-19 mitigation measures ALL application packets must be submitted online @ https://ftsmcs.ngb.army.mil/Protected/Jobs. Emailed packets will not be accepted, unless the applicant is deployed. If applicant is deployed make sure you annotate on subject line of email (DEPLOYED) name and announcement number. #### BRIEF JOB DESCRIPTION:

Responsible for maintaining personnel records, managing the OER and NCOER systems, managing the enlisted promotion system, line of duty investigations, individual mobilizations and active duty tours; advises the unit commander on soldiers, personnel readiness and strength levels; coordinates with Special Operations Command-Korea (SOCKOR) and various mobilization sites; reviews consolidated reports, statistics, and applications; prepares recommendations for

personnel actions to higher headquarter; manage the completion of in-processing and out-processing for all personnel; track the completion of awards.

Must also handle unit logistical requirements including: actions in GCCS-A, maintain a Government Purchase Card, pick up official mail, maintain the unit GSA vehicle, coordinate completion of monthly and annual inventories, prepare for COMET and CSDP inspections, order uniform items for M-Day soldiers, issue unit clothing items.

Preference will be given to applicants who: are Airborne qualified, have a TS clearance or open T5 investigation, have ever been a Government Purchase Card holder, hold the 92Y MOS in addition to 42A, or have been assigned to a Special Operations Forces (SOF) unit.
