Must be a current on-board AGR in the State of CO within the grade(s) of E8 and E9.

AREA OF CONSIDERATION: This position is open to the grades of E8 to E9.

INSTRUCTIONS FOR APPLYING: The documents listed below ARE THE ONLY AUTHORIZED documents to be submitted. If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.

- 1. Letter to the Board stating why you should be considered for this position. Include previous assignments, accomplishments, vision, and initiatives. Please include a good email address and contact phone number. Do not exceed 2 pages.
- 2. Copy of correctly formatted biography.
- 3. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
- 4. Photocopy of last 5 NCOERs (must submit memorandums for gaps in NCOERS and service members with DOR less than 5 years).
- 5. Certified Selection Board Copy of Soldier Record Brief (SRB) w/ ASVAB scores
- 6. NGB Form 23b, RPAM Statement (National Guard only).
- 7. Copy of all DD214's / NGB 22's showing all prior service.
- 8. Security Clearance Verification Memo
- 9. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
- 10. DA 705 with passing record ACFT score and HT/WT annotated. IAW NGB PPOM 22-023, individuals applying for AGR positions will require a passing record ACFT within 6 months of their packet submission.
- 11. DA 5500 or 5501-R if applicant does not meet HT/WT standards
- 12. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.

#### POSITION COMPATIBILITY REQUIREMENTS:

The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 00X

#### MINIMUM APPOINTMENT REQUIREMENTS:

- 1. Applicants must be on a current CSM Best Qualified List or must be a current CSM.
- 2. Must be currently enrolled Phase I, Term I complete, or a graduate of the USASMA
- 3. Must be eligible for HQDA appointment to CSM through NGB Nomination.
- 4. Previous Battalion CSM / Directorate SGM experience is preferred (not required).
- 5. Successful 1SG experience preferred, but not required
- 6. IAW AR 600-8-19 Current AGR Soldiers must have 18 Months in their current assignment if they were promoted to be eligible to apply for the lateral assignment.
- 7. PCS funds subject to availability.
- 8. All application packets must be submitted online @ https://ftsmcs.ngb.army.mil/Protected/Jobs. Emailed packets will not be accepted, unless the applicant is deployed. If applicant is deployed, make sure you annotate on subject line of email (DEPLOYED) name and announcement number. Deployed applicants should send application emails to ng.co.coarng.list.agr@army.mil.

#### **BRIEF JOB DESCRIPTION:**

The Basic Leader Course Commandant is in charge of one of the Army's first and foremost multicomponent cadre NCOAs, conducting 11 BLC courses per year with a student load of 185 per class. As the Commandant, you are the CSM and the "Commander" of an 05 BN level command, as BLC is an NCO led and ran BN. Additionally, the Commandant is the liaison with 4ID DCSM, ARNG-TRI, NCOLCOE, TRADOC, and HRC on all matters pertaining to the conduct of BLC and the One-Army School System (OASS), life cycle and talent management of cadre and staff, accessions process for SSGLs and SGLs, student appeals process and all other administrative actions relating to BLC. The Commandant is a highly visible position within the Total Army School System and is accountable to multiple entities for execution of all schoolhouse activities.
