1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
2. Copy of Service School Academic Evaluation Report for MCCC (DA 1059)
3. Photocopy of last 3 OERs (must submit memorandums for gaps in OERS).
4. Certified Selection Board Copy of Officer Record Brief (ORB)
5. NGB Form 23b, RPAM Statement (National Guard Only)
6. Copy of all DD214's / NGB 22's showing all prior service.
7. Security Clearance Verification Memo
8. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
9. DA 705 with passing record ACFT score and HT/WT annotated dated within the last 6 months.
10. DA 5500 or 5501-R if applicant does not meet HT /WT standards.
11. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.

POSITION COMPATIBILITY REQUIREMENTS:

The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 11A

MINIMUM APPOINTMENT REQUIREMENTS:

1. Must be 11A qualified
2. MCCC complete, post-company command. Additional staff experience, particularly in operations, preferred
3. AGR Soldiers on initial tours are stabilized for the first 18 months and are ineligible to apply for this position.
4. PCS funds subject to availability.
