WHO MAY APPLY:

Must be a current member of the CO National Guard within the grade(s) of W1 and W2.

AREA OF CONSIDERATION: This position is open to the grades of W1 to W2.

INSTRUCTIONS FOR APPLYING: The documents listed below ARE THE ONLY AUTHORIZED documents to be submitted. If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.

- 1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
- 2. Photocopy of last 5 OERs (Must submit memos for gaps in OERs).
- 3. Certified Selection Board Copy of Officer Record Brief (ORB)
- 4. Copy of all DD214's / NGB 22's showing all prior service.
- 5. NGB Form 23b, RPAM Statement (National Guard only).
- 6. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
- 7. Security Clearance Verification Memo
- 8. Copies of any civilian certifications
- 9. Resume

10. DA 705 with passing record ACFT score and HT/WT annotated. IAW NGB PPOM 22-023, individuals applying for AGR positions will require a passing record ACFT within 6 months of their packet submission.

- 11. DA 5500 or 5501-R if applicant does not meet HT /WT standards.
- 12. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.

POSITION COMPATIBILITY REQUIREMENTS:

The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 153L

MINIMUM APPOINTMENT REQUIREMENTS:

- 1. Applicant must be 153L MOS qualified.
- 2. Must be a Functional Check Pilot or be able to obtain qualification as UH72 qualified FCP within one year of accepting the position
- 3. FAA A&P certified is preferred but not required.
- 4. Background in maintenance/maintenance management
- 5. PCS funds subject to availability.
- 6. AGR Soldiers on initial tours are stabilized for the first 18 months and are ineligible to apply for this position.

BRIEF JOB DESCRIPTION:

This position is the primary production control conduit for the LUH-72 program. Manage and track scheduled maintenance through DA Form 2408-18 inspections. Balance scheduled maintenance and unscheduled maintenance by prioritizing work orders, ensuring aircraft maintenance is accurately documented, and employing support agencies. Ensure maintenance forms are maintained I.A.W common Army and FAA standards and that the LIS reflects accurate aircraft status at all times. Accurately capture the time each aircraft spends as FMC, PMC, NMC and NMCS for the 1352 report. Ensure technicians initiate action on any fault within 72 hours of fault discovery. Coordinate COAASF LUH-72 helicopter fleet maintenance, and transfers performed by or coordinated with internal and external organizations. Effectively prioritize work, and efficiently apply resource management IAW ATP 3-04.7 Manage the LUH-72 fleet in accordance with DA standards, Maintenace Officer direction, and commander guidance. Support the LUH-72 FHP for the FY by working closely with ATP manager and ATP Commander to accomplish organizational mission goals. Oversee and manage quality control. Attend routine meetings to brief LUH program status, request higher-level assistance, and maintain communication flow with Maintenance Leadership. Additionally, this position ensures technicians are actively working within the position description they were hired for and/or the assigned additional duties. Execute tasks assigned by the Maintenance Officer or ALMO in support of the flight company commander requirements. Manage administrative tasks to ensure that employees stay engaged. This encompasses a variety of routine tasks such as new employee onboarding, leave management, mentorship/training, and performance management. Maintain air crew member status as a Readiness Level 1 Pilot. Conduct required training IAW ATP references. Respond to mission requests as a pilot during state emergencies and other requests including test flights
