Must be a current on-board AGR in the State of CO within the grade(s) of E8 and E8.

AREA OF CONSIDERATION: This position is open to the grades of E8.

INSTRUCTIONS FOR APPLYING: The documents listed below ARE THE ONLY AUTHORIZED documents to be submitted. If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.

- 1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
- 2. Photocopy of last 5 NCOERs (must submit memorandums for gaps in NCOERS and service members with DOR less than 5 years).
- 3. Copy of all DD214's / NGB 22's showing all prior service.
- 4. Security Clearance Verification Memo
- 5. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
- 6. NGB Form 23b, RPAM Statement (National Guard Only)
- 7. Copy of Soldier Talent Profile (STP) w/ ASVAB scores dated within 3 months.
- 8. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.
- 9. DA 5500/5501-R if applicant does not meet HT/WT table.

POSITION COMPATIBILITY REQUIREMENTS:

The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 15Z

MINIMUM APPOINTMENT REQUIREMENTS:

- 1. Must be 15Z qualified
- 2. Must possess a current Secret clearance.
- 3. IAW AR 600-8-19 Current AGR Soldiers must have 18 Months in their current assignment if they were promoted to be eligible to apply for the lateral assignment.
- 4. PCS funds subject to availability.
- 5. AGR Soldiers on initial tours are stabilized for the first 18 months and are ineligible to apply for this position.
