1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
 2. NGB Form 23b, RPAM Statement (National Guard only).
 3. Photocopy of last 3 NCOERs (Must submit memos for gaps in NCOERs and Service Members with DOR less than 3 years).
 4. Security verification memo dated within the last 3 months
 5. Army - Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
 6. Copy of all DD214's / NGB 22's showing all prior service.
 7. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.
 8. Soldier Talent Profile (STP) dated within 3 months.
 9. Individual Training Report (ITR) from DTMS showing passing ACFT and Height/Weight within the last six months

POSITION COMPATIBILITY REQUIREMENTS:
The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 13M

- MINIMUM APPOINTMENT REQUIREMENTS:
1. Must be 13M MOS qualified.
 2. AGR Soldiers on initial tours are stabilized for the first 18 months and are ineligible to apply for this position.
 3. Must possess a current Secret clearance.
 4. PCS funds subject to availability.

 6. IAW AR 600-8-19 Current AGR Soldiers must have 18 Months in their current assignment if they were promoted to be eligible to apply for the lateral assignment.
