If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. **Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.**

1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
  2. Copy of Soldier Talent Profile (STP) w/ ASVAB scores dated within 3 months.
  3. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
  4. Photocopy of last 3 NCOERs (Must submit memos for gaps in NCOERs and Service Members with DOR less than 3 years).
  5. NGB Form 23b, RPAM Statement (National Guard Only)
  6. Security verification memo dated within the last 3 months
  7. Individual Training Report (ITR) from DTMS showing passing ACFT and Height/Weight within the last six months
  8. Copy of all DD214's / NGB 22's showing all prior service.
  9. Soldier Talent Profile (STP) dated within 3 months.
  10. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.

POSITION COMPATIBILITY REQUIREMENTS:  
The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 31B

- MINIMUM APPOINTMENT REQUIREMENTS:
1. Must be 31B MOS qualified with 2A ASI.
  2. Must be able to possess a SECRET clearance
  3. AGR Soldiers on initial tours are stabilized for the first 18 months and are ineligible to apply for this position.
  4. All application packets must be submitted online @ <https://ftsmcs.ngb.army.mil/Protected/Jobs>. Emailed packets will not be accepted, unless the applicant is deployed. If applicant is deployed, make sure you annotate on subject line of email (DEPLOYED) name and announcement number.   5. IAW AR 600-8-19 Current AGR Soldiers must have 18 Months in their current assignment if they were promoted to be eligible to apply for the lateral assignment.
  6. PCS funds subject to availability.

Supervises specific human resources functions in the unit. Advises CMD Team on Soldiers, personnel readiness, and strength levels of supported reporting units. Reviews consolidated reports, statistics, applications, and prepares recommendations for personnel actions to higher headquarters. Reviews and prepares reports and data on strength (gains/losses) of personnel and makes duty assignments of enlisted personnel. Reviews cyclic and other reports to assess system performance. Inputs and submits certain pay functions in My Unit Pay for the unit.
