WHO MAY APPLY:

Must be a current on-board AGR in the State of CO within the grade(s) of W4 and W4.

AREA OF CONSIDERATION: This position is open to the grades of W4.

INSTRUCTIONS FOR APPLYING: The documents listed below **ARE THE ONLY AUTHORIZED** documents to be submitted. If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. **Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position**.

1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).

- 2. Photocopy of last 5 OERs (Must submit memos for gaps in OERs).
- 3. Copy of all DD214's / NGB 22's showing all prior service.
- 4. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
- 5. Security Clearance Verification Memo
- 6. NGB Form 23b, RPAM Statement (National Guard Only)
- 7. Copy of Soldier Talent Profile (STP) w/ ASVAB scores dated within 3 months.
- 8. Individual Training Report (ITR) from DTMS showing passing ACFT and Height/Weight within the last six months

9. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.

POSITION COMPATIBILITY REQUIREMENTS:

The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 154F

MINIMUM APPOINTMENT REQUIREMENTS:

- 1. Applicants who are 154F MOS qualified may apply.
- 2. Must be CH-47F Instructor Pilot qualified
- 3. Must have 2000 hours of flight experience
- 4. Required to maintain flight status.
- 5. Prefer CH-47F MTP, if not qualified must be willing to attend MTP/AMOC
- 6. Prefer time teaching at an Aviation school (Rucker, WAATS, EAATS, etc.).
- 7. AGR Soldiers on initial tours are stabilized for the first 18 months and are ineligible to apply for this position.

8. IAW AR 600-8-19 Current AGR Soldiers must have 18 Months in their current assignment if they were promoted to be eligible to apply for the lateral assignment.

9. PCS funds subject to availability.

10. Must be able to possess a SECRET clearance

BRIEF JOB DESCRIPTION:

Serves as an Instructor Pilot for Power Management and Mountain qualification. Teach ground school to aircrew of multiple airframes and DoD services. Assist the commander in developing and implementing the unit aircrew-training program (ATP) for the CH-47. Provide quality control for the CH-47 ATP via the commander's standardization program. Along with their primary responsibilities, they mentor and professionally educate all unit crew members. The applicant will provide expertise on unit, crew, and collective training to the commander, and perform the following functions:

- · Serves as member of the battalion standardization committee
- Advises commander on development of commander's task list (CTL).
- Monitors unit standardization and ATPs.
- Maintains unit individual aircrew training folders (IATFs).
- Monitors unit no notice programs
- · Attend training meetings
- Administer the Total Army School System (TASS) accreditation process for HAATS

· Conduct Maintenance Test Flights as required in the CH-47

Prefer applicant to be an CH-47F IP & MTP. Must have a minimum of 2000 hours of total flight time. 250 hours of Mountain Flight Experience is preferred. Must have experience conducting classroom instruction and be able to speak in front of large groups. Preferred time teaching at an Aviation school (USAACE, WAATS, EAATS, FWAATS). Preferred graduate of the HAATS Mountain Qualification course. Prefer AWOAC complete at a minimum. Additionally, prefer a TASS accreditation specialist or experienced in TASS accreditation. Applicant should have experience in teaching foreign students in the CH-47. Applicant should possess superior interpersonal skills. PCS funds may not be available.
