Must be a current on-board AGR in the State of CO within the grade(s) of E6 and E6.

AREA OF CONSIDERATION: This position is open to the grades of E6.

INSTRUCTIONS FOR APPLYING: The documents listed below ARE THE ONLY AUTHORIZED documents to be submitted. If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.

- 1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
- 2. Photocopy of last 3 NCOERs (Must submit memos for gaps in NCOERs and Service Members with DOR less than 3 years).
- 3. Copy of all DD214's / NGB 22's showing all prior service.
- 4. NGB Form 23b, RPAM Statement (National Guard only).
- 5. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
- 6. Security Clearance Verification Memo
- 7. Individual Training Report (ITR) from DTMS showing passing ACFT and Height/Weight within the last six months
- 8. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.

#### POSITION COMPATIBILITY REQUIREMENTS:

The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 92A

## MINIMUM APPOINTMENT REQUIREMENTS:

- 1. Must be 92A MOS qualified.
- 2. Must possess a current Secret clearance.
- 3. PCS funds subject to availability.
- 4. Per the AGR Stabilization Policy dated 27 May 2025, AGR Soldiers serving less than 36 months in their current assignment are ineligible for application unless the announcement pertains to a promotion opportunity.
- 5. All application packets must be submitted online @ https://ftsmcs.ngb.army.mil/Protected/Jobs. Emailed packets will not be accepted, unless the applicant is deployed. If applicant is deployed, make sure you annotate on subject line of email (DEPLOYED) name and announcement number. ## **BRIEF JOB DESCRIPTION:**

Applicant will perform maintenance management and warehouse functions in order to maintain equipment records using GCSS-A Army Application. Soldier will oversee incoming parts and equipment, simplify and standardize maintenance data, and raise the quality and accuracy of performance, cost, and parts data through improved maintenance management. Plans and analyzes operational data and reports to ascertain conformity with established policies, work standards and procedural directives. Reconciles issues in automated supply accounting systems, maintenance records for all classes of supply except CL V, CL VIII. Ensures compliance with current regulations and directives pertaining to financial inventory, accounting and stock funding.
