AREA OF CONSIDERATION: This position is open to the grades of **W2 to W4**.

INSTRUCTIONS FOR APPLYING: The documents listed below **ARE THE ONLY AUTHORIZED** documents to be submitted. If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. **Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.**

1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
2. Photocopy of last 5 OERs (Must submit memos for gaps in OERs).
3. Copy of all DD214's / NGB 22's showing all prior service.
4. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
5. Security Clearance Verification Memo
6. Copy of Soldier Talent Profile (STP) w/ ASVAB scores dated within 3 months.
7. DA 5016 from My Retirement Points tile on IPPS-A or most recent NGB 23A (RPAM) from iPERMS
8. Report from ATIS showing passing AFT and Height/Weight within the last six months (DA 705 and DA 5500/5501 accepted in lieu of ATIS report)
9. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.
10. Exception to Policy (ETP) memo for COARNG AGR Soldiers who are under 36 months in their current assignment. Does not apply for promotion opportunity announcements

POSITION COMPATIBILITY REQUIREMENTS:

The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 155A

MINIMUM APPOINTMENT REQUIREMENTS:

1. Must have current Secret Clearance
2. Current and qualified Army Aviator
3. Minimum hours 500 total
4. Minimum 250 hours Army PIC
5. PCS funds subject to availability.
6. Army C-26 qualification required
7. Minimum of 5 years of service available to unit

8. Per the COARNG AGR Stabilization Policy dated 7 September 2025, AGR Soldiers serving less than 36 months in their current assignment are ineligible for application unless the announcement pertains to a promotion opportunity or an Exception to Policy Memo (ETP) is attached with application.

BRIEF JOB DESCRIPTION:

Pilots and commands fixed-wing utility aircraft under tactical and nontactical conditions; operates aircraft during all types of meteorological conditions during day and night; transports passengers and cargo; routinely performs instrument flight procedures, navigation, and airborne weather radar interpretation; performs military intelligence and airborne radio relay missions; maintains current flight status in accordance with established training requirements; knowledge and skills are equivalent to FAA commercial/instrument ratings on fixed wing category aircraft. Knowledge and skills may be equivalent to other FAA certificates/ratings (flight instructor, instrument instructor, ground instructor, airline transport pilot, flight engineer, etc.) or the applicant may be trained on additional categories of aircraft.
