Must be a current member of the National Guard within the grade(s) of E6 and E6.

AREA OF CONSIDERATION: This position is open to the grades of E6.

INSTRUCTIONS FOR APPLYING: The documents listed below ARE THE ONLY AUTHORIZED documents to be submitted. If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.

- 1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
- 2. Photocopy of last 3 NCOERs (Must submit memos for gaps in NCOERs and Service Members with DOR less than 3 years).
- 3. Certified Selection Board Copy Enlisted Record Brief (ERB)
- 4. NGB Form 23b, RPAM Statement (National Guard only).
- 5. Copy of all DD214's / NGB 22's showing all prior service.
- 6. Security Clearance Verification Memo
- 7. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
- 8. DA 705 with passing APFT/ACFT and HT/WT annotated. IAW NGB PPOM 22-023, a current passing APFT score is valid for use as the ACFT requirement until 31 March 2023.
- 9. DA 5500 or 5501-R if applicant does not meet HT /WT standards.
- 10. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.

## POSITION COMPATIBILITY REQUIREMENTS:

The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 18B

# MINIMUM APPOINTMENT REQUIREMENTS:

- 1. Must be 18 series MOS qualified to apply for this position.
- 2. Must be able to become jumpmaster qualified within 12 months.
- 3. Must possess a current Secret clearance.
- 4. AGR Soldiers on initial tours are ineligible to apply for this position.
- 5. PCS funds subject to availability.

Must obtain and maintain access to DAMPS, DISS, DTS, Citibank Travel Cards, APACS, RFMSS, TAMIS, IPPS-A, ATRRS.
