WHO MAY APPLY:

Must be within the grade(s) of O3 and O4.

AREA OF CONSIDERATION: This position is open to the grades of O3 to O4.

INSTRUCTIONS FOR APPLYING: The documents listed below ARE THE ONLY AUTHORIZED documents to be submitted. If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.

- 1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
- 2. Photocopy of last 5 OERs (Must submit memos for gaps in OERs and Service Members with DOR less than 5 years).
- 3. Certified Selection Board Copy of Officer Record Brief (ORB)
- 4. Copy of all DD214's / NGB 22's showing all prior service.
- 5. NGB Form 23b, RPAM Statement (National Guard only).
- 6. Security Clearance Verification Memo
- 7. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
- 8. DA 705 with HT/WT annotated. IAW HQDA EXORD 164-20, during the COVID-19 mitigation measures, a current passing APFT score and HT/WT is valid for use as the APFT and HT/WT requirement.
- 9. DA 5500 or 5501-R if applicant does not meet HT /WT standards.
- 10. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.

POSITION COMPATIBILITY REQUIREMENTS:

The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 72A

MINIMUM APPOINTMENT REQUIREMENTS:

- 1. Must be 72A series MOS qualified to apply for this position.
- 2. 72B/D/E are also eligible but must be approved by the ARNG.
- 3. PCS funds subject to availability.
- 4. Applicants must submit letter of recommendation.
- 5. Must possess a current Secret clearance
- 6. Selectee must understand that individual and collective team training investments mandate that selection/assignment to the CST requires a minimum three year commitment.
- 7. AGR Soldiers on initial tours are stabilized for the first 18 months and are ineligible to apply for this position.
- 8. All application packets must be submitted online @ https://ftsmcs.ngb.army.mil/Protected/Jobs. Emailed packets will not be accepted, unless the applicant is deployed. If applicant is deployed, make sure you annotate on subject line of email (DEPLOYED) name and announcement number. BRIEF JOB DESCRIPTION:

The Nuclear Medical Science Officer (NMSO) is the principal operator of the Analytical Laboratory System, a crew-served mobile laboratory system used to analyze chemical, biological, radiological, and nuclear (CBRN) materials. Advises the Incident and CST Commanders on a variety of health-related issues involving the affected population. Acts as a resource regarding the potential spread of causative agent(s) and potential effects on the population. Provides advice on methods to control the affected area and begin or cease quarantine procedures. Assimilate information collected by the reconnaissance teams and translates relevant data into meaningful information for the commanders. Provides recommendations for down range analyses and collection of samples, based upon the reconnaissance team's findings.

Additional Information: Civil Support Teams are fast paced with an abundance of additional training and TDY. Applicants must be willing to relocate within a 60-minute commute to Buckley SFB and be willing to serve at a minimum of 36 months after the completion of CSSC IAW CNGBM 3501.00. Applicants must attend the Civil Support Skills Course (CSSC) at the next available course after being placed on the UMR. Applicants must hold the AOC of 72A. In order to be considered for 72A, applicants must have completed, at a minimum, a bachelor's degree from an educational program accredited by the Council on Education for Public Health (CEPH) or an agency acceptable to the Surgeon General with a major in a public health-relevant field. Preferred majors include public health, environmental health, industrial hygiene, environmental science, epidemiology, and safety management. Degrees with 45 semester hours of mathematics, physics, chemistry, biology and/or

physical sciences may also be considered. Candidates are highly encouraged to review the qualifications for the award of the MOS in DA PAM 611-21 and DA Pam 600-3. 72B/D/E are also eligible but must be approved by the ARNG.
