WHO MAY APPLY:

Must be a current member of the CO National Guard within the grade(s) of E6 and E6.

AREA OF CONSIDERATION: This position is open to the grades of E6.

INSTRUCTIONS FOR APPLYING: The documents listed below ARE THE ONLY AUTHORIZED documents to be submitted. If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.

- 1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
- 2. Certified Selection Board Copy of Soldier Record Brief (SRB)
- 3. Photocopy of last 5 NCOERs (must submit memorandums for gaps in NCOERS and service members with DOR less than 5 years).
- 4. Copy of all DD214's / NGB 22's showing all prior service.
- 5. NGB Form 23b, RPAM Statement (National Guard only).
- 6. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
- 7. Security Clearance Verification Memo
- 8. DA 705 with passing record ACFT score and HT/WT annotated. IAW NGB PPOM 22-023, individuals applying for AGR positions will require a passing record ACFT within 6 months of their packet submission.
- 9. DA 5500 or 5501-R if applicant does not meet HT/WT standards
- 10. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.

POSITION COMPATIBILITY REQUIREMENTS:

The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 92Y

MINIMUM APPOINTMENT REQUIREMENTS:

- 1. Applicant must be 92Y MOSQ
- 2. Must be Airborne qualified or become Airborne qualified within 12 months of hire.
- 3. AGR Soldiers on initial tours are stabilized for the first 18 months and are ineligible to apply for this position.
- 4. IAW AR 600-8-19 Current AGR Soldiers must have 18 Months in their current assignment if they were promoted to be eligible to apply for the lateral assignment.
- 5. PCS funds subject to availability.
- 6. Must possess a current Secret clearance.
- 7. All application packets must be submitted online @ https://ftsmcs.ngb.army.mil/Protected/Jobs. Emailed packets will not be accepted, unless the applicant is deployed. If applicant is deployed, make sure you annotate on subject line of email (DEPLOYED) name and announcement number. BRIEF JOB DESCRIPTION:

Serves as the Commander's representative on all supply issues pertaining to the request, receipt, issue, and accountability of individual, organizational, installation, and expendable supplies and equipment. Assists in property accountability through the Global Combat Support System-Army (GCSS-A), schedules and performs preventative and organizational maintenance on weapons and other sensitive items, and manages over \$20 million in MTOE equipment. Manages both P2 (Army) and P11 (SOF) equipment, SPEAR/SSAVIE, and procurement to meet mission requirements. Ensures critical assets are on hand or ordered, monitors all sensitive items, and unit inventories. Supports the commander in the Supply Discipline Program; prepares daily, weekly, and monthly reports sent to higher headquarters. Initiates Financial Liability Investigations of Property Loss (FLIPL). Maintains custodial responsibility of Unit's equipment.
