WHO MAY APPLY:
Must be a current member of the National Guard within the grade(s) of W2 and W4.

AREA OF CONSIDERATION: This position is open to the grades of **W2 to W4**.

INSTRUCTIONS FOR APPLYING: The documents listed **WILL** be submitted "AS A MINIMUM". If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the soldier as eligible. **Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.**

1. NGB 34-1 (dated 20131111) must be complete with original signature and memos (Must submit explanation memos for yes selections except for question #9 and #17).
2. Photocopy of last 5 OERs (Must submit memos for gaps in OERs).
3. Certified Selection Board Copy of Officer Record Brief (ORB)
4. Copy of all DD214's / NGB 22's showing all prior service.
5. NGB Form 23b, RPAM Statement (National Guard only).
6. DA 759-1 Individual Flight Record and Flight Certificate
7. Security Verification Memo.
8. Medical Protection System Individual Medical Readiness (IMR) dated within the last 12 months.
9. DA 705 with HT/WT annotated(last 3 APFT annotated). IAW HQDA EXORD 164-20, during the COVID-19 mitigation measures, all current valid passing APFT scores remain valid until further notice.
10. DA 5500 or 5501-R if applicant does not meet HT /WT standards. IAW HQDA EXORD 164-20, during the COVID-19 mitigation measures, all current HT/WT remain valid until further notice.
11. Profiles must be attached if applicable. Pregnancy itself is not a disqualifier.

POSITION COMPATIBILITY REQUIREMENTS:
The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 153A

- MINIMUM APPOINTMENT REQUIREMENTS:
1. AGR Soldiers on initial tours are stabilized for the first 18 months and are ineligible to apply for this position.
 2. Applicant must be 153A qualified
 3. Preferred to have time teaching at an Aviation school (Rucker, WAATS, EAATS, etc.)
 4. Must be a UH60 A/L MTP.
 5. Preferred UH60M qualified.
 6. Preferred UH60M MTP qualified.
 7. Required to maintain flight status.
 8. Must be able to possess a SECRET clearance
 9. Must meet eligibility criteria in NGR 600-5 and AR 135-18, Tables 2-1, 2-2, and 2-3.
 10. meet medical standards IAW AR 40-501, Chapter 3.

BRIEF JOB DESCRIPTION:
Open to current members of the Army National Guard in the grade of CW2-CW4. Applicant must have a Secret Security Clearance or higher. Applicant must be an UH60A/L IP/MTP with CH-47 experience or UH60M experience preferred. Must have a minimum of 1750 total flight time. 250 hours of Mountain Flight Experience is preferred. Must have experience conducting classroom instruction and be able to speak in front of large groups. Preferred time teaching at an Aviation school (Rucker, WAATS, EAATS, etc). Preferred graduate of the HAATS Mountain Qualification course. Prefer AWOAC complete at a minimum. Additionally, prefer a TASS accreditation specialist or experienced in TASS accreditation. Applicant should have experience in teaching foreign students in the UH-60. Applicant should possess superior interpersonal skills. PCS funds may not be available. HAATS is in an extreme high cost of living area.

Primary Duties and responsibilities:

Serves as a Standardization Instructor Pilot for Power Management and Mountain qualification. Teach ground school to aircrew of multiple airframes and DoD services. Serve as Assist the commander in developing and implementing the unit aircrew-training program (ATP) for the UH-60. Provide quality control for the UH60 ATP via the commander's standardization program. Serves as UH-60 A/L Maintenance Test Pilot (MTP). Along with their primary responsibilities, they mentor and professionally educate all unit crewmembers. They applicant will provide expertise on unit, crew, and collective training to the commander, and perform the following functions:

- Serves as member of the battalion standardization committee
 - Advises commander on development of commander's task list (CTL).
 - Monitors unit standardization and ATPs.
 - Maintains unit individual aircrew training folders (IATFs).
 - Monitors unit no notice programs
 - Attend training meetings
 - Administer the Total Army School System (TASS) accreditation process for HAATS
 - Conduct Maintenance Test Flights as required in the UH-60
