## AREA OF CONSIDERATION:

Open to all current eligible M-Day members of the Colorado Army National Guard in the Grades of E-6 to E-7. Must be 25H qualified. Soldiers must currently hold or be eligible to obtain a Secret security clearance within one year of accepting the position. Applicants must have 36 month remaining on their enlistment contract or be willing to extend. All applicants MUST meet Chapter 3 physical standards IAW NGR 40-501 and AR 40-501.

## APPLICATION DOCUMENTATION

1. Letter to the Board stating why you should be considered for this position, including previous assignments and accomplishments. Please include current contact phone number. Do not exceed 2 pages.
2. Individual Medical Readiness Record (MEDPROS) with last Periodic Health Assessment (PHA) within 12 months of closing date of announcement.
3. Photocopy of last 5 NCOERs (memo required for gaps in NCOERs).
4. Validated Selection Board Record Brief.
5. Copy of current record DA Form 705 (IAW current guidance). Profiles must be attached, if applicable. Temporary profiles will be accepted on a case by case basis.
6. Must have a DD 5500 (Male) or 5501-R (Female) attached if body fat content test required IAW current guidance.
7. NGB 23b (RPAS Statement) retirement record current within 30 days of announcement closing date.
8. Security Clearance Validation Memo.

**Applications without all required supporting documents will be returned without consideration.**

**Qualified applicants will be contacted for interviews.** M-Day Soldiers selected to fill a vacant position may be promoted provided the Soldier is on a valid EPS list and meet all the promotion eligibility requirements. After recommendation is approved by the G1 the President of the Selection Board will contact all applicants to notify them of selection or non-selection. Technicians must verify with the HRO for job compatibility.

**PRIMARY DUTIES AND RESPONSIBILITIES:**

Plans, coordinates, and supervises installation, operation, maintenance, and management of network communication systems, including radio, tactical satellite terminals, switching, cable, and automation equipment. Supervises the installation, operation, strapping, re-strapping, preventive maintenance checks and field level maintenance on COMSEC devices. Directs restoration, and alternate routing of circuits, trunks, links, and systems. Develops and implements field level signal maintenance programs. Provides operational and technical assistance to subordinates and commanders. Verifies frequency operational requirements, network communication systems service requests, and disseminates operations information to ensure command and control communications connectivity. Requests and ensures appropriate logistical support is always available. Assimilates and reports system/network statistics. Develops and implements training programs for Signal personnel. Uses computers to process operational and administrative information. Operates system control facilities as part of Signal organization management functions

**Minimum Eligibility Criteria:**

Must meet requirements as stated in the "Area of Consideration". Must not be under a current suspension of favorable personnel actions.
