### AREA OF CONSIDERATION:

Open to current members of the Colorado Army National Guard in the Grade of E6(P) that are on a current promotion list and E7's. Current NCOES and SSD/DLC complete for grade. Soldiers must either currently hold or be eligible to obtain a Secret security clearance. All applicants MUST meet Chapter 3 physical standards IAW NGR 40-501 and AR 40-501. Applicants must have 36 months remaining on enlistment contract or be willing to extend. Must meet requirements as stated in the "Areas of Consideration". Must not be under a current suspension of favorable personnel actions. Instructor experience preferred. Must have the ability to pass the ACFT. Can not be pending any boarding actions to include medical. Basic knowledge for Rifle Marksmanship (BRM) and Primary Marksmanship Instruction (PMI) per TC 3-20.40 & 3-22.9. Basic knowledge on scheduling ranges. Soldiers who have been selected for promotion must serve in the duty position for 18 months and are ineligible to apply.

## APPLICATION DOCUMENTATION

- 1. Letter to the Board stating why you should be considered for this position, including previous assignments and accomplishments. Please include a good mailing address and contact phone number. Do not exceed two pages.
- 2. Individual Medical Readiness Record (MEDPROS) with last Periodic Health Assessment (PHA) within 12 months of closing date of announcement and HIV test less than 24 months old within 30 days after closing date.
- 3. Photocopy of last 5 NCOERs (memo required for gaps in NCOERs).
- 4. Validated Selection Board Record Brief within 30 days after closing date.
- 5. Copy of record scorecard (DA 705) (must be less than 12 months old IAW current guidance). Profiles must be attached, if applicable. Temporary profiles will be accepted on a case by case basis.
- 6. Must have a DD 5500 (Male) or 5501-R (Female) attached if body fat content test required IAW current guidance.
- 7. NGB 23b (RPAS Statement), retirement record (National Guard only).
- 8. Copy of current Driver's License.
- 9. All documents must be consolidated into one PDF.

## Applications without all required supporting documents will be returned without consideration.

Qualified applicants will be contacted for interviews. M-Day Soldiers selected to fill a vacant position may be promoted provided the Soldier is on a valid EPS list and meet all the promotion eligibility requirements. After recommendation is approved by the G1 the President of the Selection Board will contact all applicants to notify them of selection or non-selection. Technicians must verify with the HRO for job compatibility.

### **PRIMARY DUTIES AND RESPONSIBILITIES:**

Duties include but are not limited to operate, provide training on, PMCS, and perform operator level maintenance on TADSS equipment. RSO and Maneuver Damage Programs. Preparing, conducting, and recommending improvements for all aspects of Small Arms Qualification IAW TC 3-20.40 & 3.22.9. Support EST operations and training, Marksmanship training, and Range Facility Management Support Systems (RFMSS). Serves as an instructor for Basic Rifle Marksmanship (BRM) and Primary Marksmanship Instructor (PMI). Assists range operation by supporting missions for the Engagements Skill Trainer (ESTII) & Vehicle Convoy Operation Trainer (VCOT)
