#### AREA OF CONSIDERATION:

Open to current members of the Colorado Army National Guard in the Grade of E4 thru E6 that hold the 68W MOS. E6 Soldiers must be graduates of ALC and SSD2. Soldiers must either currently hold or be eligible to obtain a Secret security clearance within 1 year of accepting the position. Soldiers must be able to meet Chapter 3 physical standards IAW AR 40-501 and NGR 40-501 within 1 year of accepting the position. Soldiers must be able to meet all Aircrew training and F2 ASI training requirements within 18 months of being placed on flight status. Soldiers must meet MSO requirements for associated required training.

#### APPLICATION DOCUMENTATION

Qualified applicants must submit applications as described below to their current unit. Unit must provide and forward to the address in the Unit of Activity of this announcement. Applications received after 1700Hrs (MST) on the closing date will not be considered.

- 1. Memo stating why you should be considered for this position, including previous assignments and accomplishments. Please include a good mailing address and contact phone #. Do not exceed 2 pages.
- 2. **PHYSICAL**: Individual Medical Readiness Record (MEDPROS) with last Periodic Health Assessment (PHA) within 12 months of closing date of announcement and HIV test less than 24 months old within 30 days after closing date.
- 3. Photocopy of last 5 NCOERs (memo required for gaps in NCOERs).
- 4. DA Photograph in Class A military uniform (ASU), three-quarter or full length, taken within the last 12 months.
- 5. Certified true copy of ERB with ASVAB scores annotated.
- Copy of latest APFT Scorecard (DA 705) (must be less than 12 months old).
   Profiles must be attached, if applicable. Temporary profiles will be accepted on a case by case basis.
- 7. Copy of current RCAS APFT and HT/WT History (minimum 5 years)
  - Must have a DD 5500 or 5501-R (Female) attach if body fat content test required.
- 8. NGB 23, NGB 23b (RPAS Statement), retirement record (National Guard only)
- 9. Copy of current Driver's License
- 10. Soldiers that are flagged will NOT be considered.

Applications without all required supporting documents will be returned without consideration. Applications will be submitted to the Office and Address listed in the upper left hand corner. Qualified applicants will be contacted for interviews. After recommendation is approved the chairperson of the selection board will contact all applicants to notify them of recommendation or non-recommendation

Qualified applicants will be contacted for interviews. M-Day Soldiers selected to fill a vacant position, may be assigned to that position and may be promoted provided the Soldier is on a valid EPS list and meet all the promotion eligibility requirements. After recommendation is approved by the G1, the chairperson of the selection board will contact all applicants to notify them of recommendation or non-recommendation. Technicians must verify with the HRO for job compatibility.

# **PRIMARY DUTIES AND RESPONSIBILITIES:**

Perform scene control, scene safety, emergency treatment, monitor and stabilize the critically sick and wounded in the field and in flight. Perform crash rescue operations; Perform search and rescue operations and aero-medical evacuation of the sick and wounded; Perform high performance hoist and other complex rescue operations; Conduct MEDEVAC assessment and treatment; Perform daily preflight checks and services of medical equipment; Conduct MEDEVAC training to include lectures; cold patient loading, hot patient loading, High performance hoist operations, aircraft safety, landing zone preparation and 9 line MEDEVAC request.

# **Minimum Eliqibility Criteria:**

Must meet requirements as stated in the "Areas of Consideration". Must not be under a current suspension of favorable personnel actions.

## MEMORANDUM FOR DISTRIBUTION

SUBJECT: Flight Paramedic Board

- 1. Det. 1 C Co MEDEVAC is now accepting applications for Flight Paramedic positions from Army Medics (68W) seeking to grow their medical career. An interview process will be completed prior to consideration.
- 2. The interview will consist of submission of an initial application packet followed by an interview with a board of C Co leadership to include the Company Commander, 1SG, Flight Instructor and Senior Medic.
- 3. The applicant must include the following in the application packet at a minimum. Other substantiating documentation (auxiliary certifications, extra letters of recommendation, etc.) may also be included.
  - a) Last 3 APFTs and Height/Weight
  - b) Last 5 NCOERs (or all NCOERs if you have been rated for less than 5 years)
  - c) All medical credentialing certificates and cards (BLS, NREMT, any Advanced Provider certificates, and NREMT-P/CCP/FP-C if applicable)
  - d) Two letters of recommendation (one from your commander, one from a medical provider)
  - e) A one-page letter briefly describing your medical and/or flight career to include any civilian experience. **Have your contact information in the letterhead.**
- 4. Send the above information to the email undersigned below. After your packet is reviewed you will be contacted to schedule an interview.
