- ___ Senior Warrant Officer Letter of Recommendation (USAREC Form 3.3) with email address and phone number
- ___ Company Commander Letter of Recommendation (or applicable Company Grade UCMJ authority (USAREC Form 3.3) with email address, phone number and the following required statement :
"I CERTIFY THAT (NAME & RANK) SUCCESSFULLY PASSED THE ARMY PHYSICAL FITNESS TEST CONSISTING OF PUSH-UPS, SIT-UPS AND THE TWO MILE RUN WITH A SCORE OF (SCORE) ON (DATE); THE VERIFIED HEIGHT IS (FEET & INCHES) AND THE VERIFIED WEIGHT IS (LBS)."
- ___ Battalion Commander Letter of Recommendation (or applicable Field Grade UCMJ authority) (USAREC Form 3.3) with email address and phone number
- ___ Resume (USAREC Form 3.2) (Summary, Signature and date signed must be included)
- ___ ERB/ORB (Certified within 6 months of submission include most recent NCOES/OES level. No board brief)
- ___ Evaluations (All NCOERs/OERs and all AERs (1059s) in order newest to oldest)
- ___ Security clearance memorandum (Minimum Interim Secret or Interim Top Secret based on WO MOS)
- ___ College Transcript(s)* if applicable
- ___ Copies of Professional Certificates (Licenses or Certificates issued to Engineers, Mechanics, etc)
- ___ REDD Report/GT score verification (Air Force, Marine, Navy, Coast Guard applicants and retests)
- ___ DA Form 7434-Application for US Army Marine Certification (880A, 881A)
- ___ Other/Supporting Documentation:
 - ___ Other MOS specific required documents to include (Technician Appraisals, Civilian Evaluations, Portfolios)
 - ___ English credit document – if required
 - ___ TABE (Test of Adult Basic Education) score document – if required
 - ___ Request for Prerequisite Waiver from Soldier - if applicable
