
MINUTEMAN SCHOLARSHIP

Process



MEPS/DoDMERB, ASVAB, and Physical must be completed. (all waivers resolved)



Packet. Build MM Scholarship packet to include nomination memo.



Nominee is now a Contracted Scholarship ROTC Cadet. Minuteman scholarships can be either 2-year GRFD scholarships or DED-GRFD scholarships up to 4 years in length and guarantee that Cadets who commission as Army officers will serve in either ARNG or USAR. Minuteman scholarships require a nomination letter as part of the scholarship packet and offer either full tuition and mandatory fees or a \$10,000 flat rate Room & Board per year that covers up to 4 years/8 semesters of benefits. Minuteman scholarship awardees also receive an annual book allowance and a monthly stipend.

Minuteman Scholarship Cadets can be nominated from any State Adjutant General (TAG), any Civilian Aide to the Secretary of the Army (CASA), a Mission Support Command (MSC), or an Army Reserve Ambassador (ARA) in lengths of 2YRs up to 4YRs for a scholarship. These scholarships are limited each year and need a nomination memo with a handwritten signature from the nomination source. Deadlines for the Minuteman scholarships are 01 September for fall starts and 01 December for spring starts each year.

Qualifications include:

- Must be a US Citizen
- Must not turn age 31 by Dec 31st of Commission year
- Currently in the Reserve Component or eligible to enlist
- Ability to pass the APFT
- Meet 600-9 standards
- Pass Nomination Interview
- PMS validation
- Acceptance letter to college
- Proof of academic major
- Proof of ACT or SAT scores*
- Enroll in SROTC

*4yr MM requires 24ACT/1200SAT or be MOSQ

UNDERSTANDING SMP/GRFD OPTIONS

Simultaneous Membership Program (SMP):

The SMP gives eligible enlisted members of the ARNG and USAR an opportunity to maintain status in their Reserve Component while simultaneously attending college and participating as a contracted Cadet in the ROTC Program working towards a Commission as an Officer.

Guaranteed Reserve Forces Duty (GRFD):

The GRFD scholarship program is designed for Cadets who are interested in obtaining a commission as an officer in the Army National Guard (ARNG) or US Army Reserve (USAR) with a guarantee for a Reserve Component (RC) assignment.

A Contracted Scholarship GRFD Cadet can earn:

- Full Tuition & Fees or \$10k Room & Board per year
- CDT Stipend: \$420 per month Flat Rate (as of Fall 2018)
- Book Stipend: \$1,200 per year
- SMP-Kicker: \$350 if eligible
- Can use any GI Bill with 2-year or less GRFD Scholarship
- Cannot use MGIB Benefits with Dedicated GRFD
- Can use or State Tuition Assistance (STA)
- Masters Students eligible for 2-year GRFD

SMP Non-Scholarship: No tuition & fees or room & board scholarship. No book stipend. Can use any GI Bill benefits (if eligible), can use SMP Kicker (if eligible), can use Federal Tuition Assistance (FTA) and/or STA (if eligible), receives monthly CDT stipend and CDT/E5 Drill pay. Can compete for Active Duty.

GRFD Non-Scholarship: No tuition & fees or room & board scholarship. No book stipend. Can use any GI Bill benefits (if eligible), can use SMP Kicker (if eligible), can use FTA and/or STA (if eligible), receives monthly CDT stipend and CDT/E5 Drill pay. Has a tracked GRFD control number (can request to revoke this number to compete for Active Duty).

GRFD Scholarship: Up to 2 years of full tuition & fees (uncapped) or room & board (\$10k per year) and \$1,200 per year book stipend. Cannot use MGIB benefits unless CH30 or CH33 eligible, can use STA (if eligible), receives monthly CDT stipend, and CDT/E5 Drill pay. Has a tracked GRFD control number and will access into selected component (either USAR or ARNG only)

Dedicated GRFD Scholarship: Up to 4 years of full tuition & fees (uncapped) or room & board (\$10k per year) and \$1,200 per year book stipend. Cannot use MGIB benefits unless CH30 or CH33 eligible, can use STA (if eligible), receives monthly CDT stipend, and CDT/E5 Drill pay. Has a tracked GRFD control number and will access into component selected at time of contracting (either USAR or ARNG only).

Minuteman Scholarship: Can be either a 2-year GRFD or up to a 4 year Dedicated GRFD Scholarship and requires a nomination letter as part of the application packet. Benefits are the same as the corresponding length of the GRFD.

This CDT is a 2yr Non-Scholarship in the USAR. No tuition & fees, no room & board, and no book stipend is provided. The CDT used FTA for 2 years and received the ROTC stipend of \$420 a month. Annual training and drill pay are based on E5 pay. This CDT is also MOSQ (attended BCT & AIT) and is entitled to SR-MGIB benefits and the SMP kicker incentive. This CDT can choose to commission into the USAR, ARNG, or can compete for Active Duty. This CDT is a 3yr Dedicated GRFD Scholarship recipient in the ARNG. The CDT used the ROTC Scholarship for room & board combined with State Tuition Assistance for tuition & fees. The CDT also received the ROTC stipend of \$420 a month and the annual book stipend of \$1,200 per year. Annual Training and drill pay are based on E5 pay. SR-MGIB benefits cannot be used with this scholarship. This CDT contracted Dedicated ARNG which requires that they commission ARNG. This CDT was nominated by the State TAG and awarded a 4yr Minuteman Scholarship. The CDT used the ROTC Scholarship for room & board combined with State Tuition Assistance for tuition & fees. The CDT also received the ROTC stipend of \$420 a month and the annual book stipend of \$1,200 per year. Annual Training and drill pay are based on E5 pay. SR-MGIB benefits cannot be used with this scholarship. This CDT contracted Dedicated ARNG which requires that they commission ARNG.
